# 2009 PSSAT Meeting Minutes

At 7:04 PM, President **Nathan Haile** called the meeting to order. He said he hated to have everyone RSVP for the meal, but at last year's meeting, we ran out of food.

Nathan said the minutes from the previous meeting were published on the PSSAT web site. He asked if there were any additions or corrections to those minutes. Being none, Nathan accepted a motion and a second to accept the minutes as published. Motion passed.

Nathan called on **Lindsay Lang**, *Treasurer*, to give his report. Handouts were given to those in attendance for the 2008 Financial Report). Please refer to this handout. Lindsay reviewed the report. Nathan then asked for a motion, which was seconded, to accept the Treasurer's Report as presented. Motion passed.

Nathan called **Jon Wiedenfeld**, *Finance Committee* Chair, to make his report. Jon said there was nothing to report. Comments from the peanut gallery alluded to a possible buyout/bailout from the new administration.

Nathan called on **Dusten Russell**, *President-Elect*, *Membership Committee* Chair, to make his report. Dusten informed the group that there was one (1) new member, and one (1) member who chose not to renew.

Nathan called for the *Ethics Committee* to make their report. Chair **Kirby Griffith** was not present, so **Jessica Jobe** was asked to give the report. She said there was nothing to report.

Nathan called for the *Public Relations and Education Committee* to give their report. Chair **Dennis Brezina** was not in attendance, so Nathan presented the report for that committee. Nathan said it was hard to do anything without funding, but there would be more on this topic later. He did strongly indicate that PSSAT *does not* do anything to promote itself at the high school, and college levels.

Nathan called on **Jon Brandt**, *Webmaster*, to present his report (See handout). Jon reported a nine percent (9%) decrease from last year, as far as hits to our website. There were about 21,395 hits last year, which averages about 1,700 hits per month. There were hits from 60 countries. There were about 10 hits per month related to "Careers in Soil Science." Jon announced that this was really his last year to serve in this position and that **Ricky Lambert** would be taking over. Jon did say that there are about 16 incorrect email addresses, and there are still 27 PSSAT members without email addresses. Please check out your information with Lindsay. Nathan added that more hits to our website came in December and January, he assumed it was PSSAT members checking for information about the Annual Meeting. Nathan called on **John Sackett**, *Scholarship Committee* Chair, to present his report. John said there was only one applicant this year, but he was a good one. The 2009 PSSAT Scholarship was awarded to **Gaylen Roberts**, Texas Tech University. Gaylen was presented a check for \$1,500.00, a leather sheath stamped with PSSAT, and a pocketknife.

**Kelly Attebury**, *Past-President*, was called on to handle *the Nominations and Elections*. Kelly informed the group that four Offices were to be filled: President-Elect and Vice President (1 year terms), and Treasurer and Editor (2 year terms). Kelly thanked all those members he contacted and said he appreciated their enthusiasm. Ballots were not handed out. Instead, blank pieces of paper were given to all who were present. #### **NEW BUSINESS**

Nathan asked if there was any New Business.

### Photo Contest

**John Sackett** announced the plans for a PSSAT Photo Contest. He presented a Power Point presentation. The purpose of the Photo Contest is to have a fun competition amongst field soil scientists, increase member participation, and add an extra incentive to attend annual meetings.

The contest will be available to current members. He said, "You have got to pay to play!" Pictures are to be in jpeg format and limited to 4MB in size. Pictures from Texas only. This is a way to spruce up the website. Photographers will be given credit. There will be four or five categories such as Plants (crops and native vegetation), Soil Profiles (pit faces and road cuts), Landscapes, Animals (domestic and wild), and a Miscellaneous category. Each person will be limited to two photographs per category, with a maximum of 10 photos. It's free, and prizes will be awarded. John added that he is looking for Judges, but Judges will not be allowed to enter any photos. Suggested prizes are First Place—Framed 11 X 17 photo; Second Place—Framed 8 X 10 photo; and a Best in Show. John instructed the group to vote for the Photo Contest on the ballot.

#### Education and Outreach

**Cristine Morgan** took the floor to discuss information currently lacking on our website. She said she gets asked all the time for soils information for K-12 levels. How many of us have outreach at the K-12 level? How many of us present soils information for the Master Naturalist or Master Gardener? She suggested posting links on our website for the folks taking these classes. She suggested having a Power Point presentation available on our PSSAT Website. She asked the group to place a vote for this on the ballot. Nathan added he has received three requests to do Web Soil Survey training in the last couple of weeks. He added that a Power Point Presentations section would be something we would want to add to the website.

Nathan asked the group to vote yes or no, to changes made to the Constitution and Bylaws that updated the way the Executive Council conducts business meetings. He added that the changes were sent out with the meeting announcement and newsletter for the membership to review. Nathan asked the group to place this on the ballot, yes or no.

Nathan then took the floor to discuss Public Relations and Education. Nathan mentioned that this year PSSAT had a chance of outreach at the Soil Science Society of America Meeting in Houston, and also at the local and state Envirothon. PSSAT currently has no money dedicated to outreach. Nathan and the Executive Council met over teleconferences and discussed having booths, handouts, brochures, etc. Nathan suggested investing in a Display Board members could use at outreach events. He suggested using these display boards at universities, meetings with Society of Range Management, Texas American Society of Agronomy meetings, and High School Ag or Environmental events.

**Charlie Thompson** asked about a brochure. Nathan said he liked the idea of a brochure, and it would allow the PSSAT name to be located at several places. Nathan said the Display Board would be kept

small for shipping purposes and would hopefully involve participation of PSSAT members. Nathan said how much would it cost. He added our dues are currently \$25.00. (See PR&E flyer)

Nathan called on **Jon Wiedenfeld** to give a report on other state associations, dues, and meetings. Jon did a Google search for professional soil scientist associations. He said common dues are about \$20 to \$25 per year. His results are:

- California PSSAC—nice website, \$35 dues, one weekend meeting per year that moves around the state, includes a tour of some kind
- Missouri—nice website, \$10 dues, \$100 lifetime membership fee, have items for Silent Auction on website, t-shirts for sale, member lists, annual meeting and tour
- Wisconsin—fair website, \$20 dues, award two \$200 scholarships per year, have annual meetings with tours that move around the state

Alabama—primitive website, list of members and speakers, membership application on website, no photographs or links

Oklahoma—primitive website, \$25 dues, list of members, annual meetings include a speaker

At this time, Nathan opened the floor for discussion. (I might add that there was a lot of it!!!!)

**Wayne Gabriel** said he was not excited about the potential dues increase, but he might pay more for good PR. He added the website is 24/7, and if we purchased posters they would have to be carried around, and money would be needed for mailing or shipping. **Dennis Williamson** commented at stock shows there might be more recruiting than having a booth at a convention, and you could do 17 posters for the price of a display board. **Wayne Hudnall** offered Texas Tech University to make the posters for free. Wayne Gabriel added that he was not opposed to the increase in dues, but we needed to use something where more people could view it.

Nathan, in trying to discuss what we could get with a dues increase, stated that for a \$5 increase in dues, with 80 active PSSAT members, this would net \$400.

**Cristine Morgan** suggested having the posters on file and emailing them to Kinko's, where they could print them. That way there would be no reason to ship anything. **Gary Harris** added the files could be "pdf'd". Wayne Gabriel said a poster would be nice, especially if it was professionally made.

Nathan added we could use the money for the promotion of the scholarship. Wayne Gabriel asked if we got enough promotion of PSSAT from scholarship recipients. Nathan added that those members who gave additional monies to the Scholarship Fund and probably intended that money be used for the scholarship. Do we take some money from the Scholarship Fund to create a Public Relations and Education Fund? If so, we need to amend the Constitution and Bylaws for this change in dues.

**Moye Rutledge** commented that the Extension Service is charged with educating folks about soil surveys. He said he had only seen it once in his life. We need to ask them if they want to join us in this endeavor. Nathan said it was a good idea to work jointly with NRCS, PSSAT, and the Extension Service. Moye Rutledge said the NRCS, University of Arkansas, and Arkansas State already work together.

**Eddie Bearden** said he always wrote a check for additional money to the Scholarship Fund, and was not ashamed to do so. A motion was made and seconded, "to use excess funds from the Scholarship Fund to fund a Public Relations and Education Fund". Motion passed.

**Ed Janak** asked if we should rename the Scholarship Fund to the Scholarship Fund-Public Relations and Education Fund. Wayne Gabriel said if we were not careful, the Scholarship Fund might dry up.

**Mike Risinger** said he thought our dues were too low and that he had no problem using Scholarship Fund monies to fund other projects. He said there were many generous donors in this group. **Sidney Paulson** asked if we were bringing in more money than we were spending. Nathan said if we do not use the money, we are okay. Sidney Paulson offered to let the Public Relations and Education Committee do this for a trial period of one year, and see what happens after that time period.

**Dan Kowalski** suggested using \$2,000 of the Scholarship Fund, and to transfer it to the Public Relations and Education Fund. **Dennis Williamson** commented that travel costs, per diem costs, etc. might be involved. Also, \$2,000 would cover booth space at two events.

**Travis Waiser** said meetings of the SSSA and other meetings where professional soils scientists were not the intent of our outreach. He suggested attending stock shows, where young kids in ag were located, and use this event as a recruitment for interest in soils. **James Gordon** said High School visits were free. Dennis Williamson added the NRCS had six summer soil scientist positions with currently no applicants. **Susan Casby-Horton** offered that other professions, like Engineers etc. might join with us.

**Mitte Muse** suggested of the new \$40 dues, we dedicate \$15 for a period of two years for the Public Relations and Education Committee to use, and revisit this in two years. Someone called the question. Jon Brandt said we could survey the membership online, using the website. Nathan asked if there was a second, the motion passed. There were several nay votes!

He asked if PSSAT would be willing to contribute to this contest. A motion was made, and seconded, "that PSSAT contribute \$1,000 to the National Collegiate Soil Judging Contest in 2010 at Texas Tech University." Motion passed. One nay vote by Wayne Gabriel, an Aggie.

Wayne Hudnall announced Texas Tech will host the National Soils contest in 2010

At 8:15 PM, **Jamie Pitchford**, an Environmental Specialist with Luminant Mining LCC, gave her presentation on Post Mine Soils at several Luminant Mines in Texas. After her presentation, she added that, in May, soil pits will be open at Monticello Mine and to contact her if anyone was interested.




# Annual Report for 2008-2009 PSSAT Web Site http://pssat.org As Prepared by Jon Brandt, PSSAT Webmaster

## Web Site


The PSSAT web site has been on the Internet for approximately ten years. Ricky Lambert and Craig Byrd first developed the web site. Jon Brandt joined the effort later in 1999. The PSSAT web site first migrated from a free Geocities page to one located on an Austin server. In 2002, we obtained the *pssat.org* domain name and began using Datarealm, which has provided web hosting at a nonprofit rate of \$134/year. The PSSAT site received **21,395** visits (99,000+ hits) since last year's PSSAT annual meeting (a 9% decrease from 2007-2008). This was our first drop in yearly visitation, as we had experienced annual increases since 2001. Our web site continues to be the first or second result that comes up with a "*PSSAT*" query on all of the major Internet search engines. The following provide the details of the web activity:

Average Visits per Month (since Jan. 2008): 1,783

 The top five types of domains visiting the PSSAT web site: Networks; U.S. Commercial; U.S. Educational; Non-Profit Organizations; and U.S. Government.



- We received hits from sixty countries, the same as last year. The most visits came from the following: Ireland; the Russian Federation; Canada; Germany; and Mexico.
- 3. There were six search phrases that were used the most to find our site (since January 2008):

  - Texas Soil Map(s)
  - PSSAT

## CHANGES TO THE CONSTITUTION

The following are impending changes to PSSAT that have been suggested. A survey was completed and the members were in agreement that a student membership was needed, the amendments of which are in red below. These modifications need to be reviewed and voted on by the members. ## ARTICLE III.—MEMBERSHIP

Section 1. Membership in the Association may be accepted or terminated as provided in the Bylaws.

Section 2. There shall be classes of membership as follows:

- a. Member
- b. Associate Member
- c. Student Member
- d. Honorary Member
- e. Sustaining Member

#### Section 3. Membership Qualification

a. **Member** – Eligibility for membership consists of a B.S. degree in Soil Science or other fouryear degree program and 15 semester hours (23 quarter hours) credit in soil science. All members must be approved by the membership committee.

b. **Associate Member** – Professionals interested in the aims and goals of the Association may be considered qualified to become associate members upon the approval of the membership committee.

c. **Student Member** – Students (high school through senior in college) interested in the aims and goals of the Association may be considered qualified to become student members upon the approval of the membership committee.

d. **Honorary Member** – Shall be one whom the Association desires to honor because of outstanding contribution to the profession, state or nation.

e. **Sustaining Member** – Shall be an individual or organization wishing to support the aims and goals of the Association in a special way by making a contribution to the Association of \$50.00 or more.

## Section 4. Membership Privileges

a. All classes of membership shall be permitted to attend meetings of the Association and to take part in the discussion of all business matters.

b. Only a Member shall hold the office of President, President-Elect, Vice President, Treasurer, or Editor.

c. All classes of membership, except student members, may serve on committees, but only Members may chair committees.

## Section 5. Voting Privileges

Only members as defined in Section 3a above shall have voting privileges in matters pertaining to the affairs of the Association, including the election of officers.

# CHANGES TO THE BYLAWS OF THE PROFESSIONAL SOIL SCIENTISTS ASSOCIATON OF TEXAS

### ARTICLE IV.—DUES

Section 1. Dues are payable to the Treasurer upon receipt of a dues statement by the date of the annual meeting. Annual dues for members and associate members shall be forty dollars (\$40.00). Fifteen dollars (\$15.00) for the Scholarship Fund, ten (\$10.00) dollars for operations, and fifteen dollars (\$15.00) for Public Relations and Education for 2009 and 2010. Dues for student members shall be ten dollars (\$10.00).

Section 2. Honorary members will not be assessed dues.
